**The Company completed an exploration program on the Jackson Manion North Property, with the work consisting of mapping, prospecting and humus sampling. The mapping and sampling focussed on the areas around the Discovery Trench, the X-Zone, the Channel Anomaly, and a possible southern extension of the X-Zone.**

**A total of 33 rock grab samples were retrieved for assay along with 89 humus samples on 10 east-west lines. The samples were submitted to Accurassay Labs for analysis.**

**Management has as visited Brazil to look for iron ore properties suitable for acquisition.**
